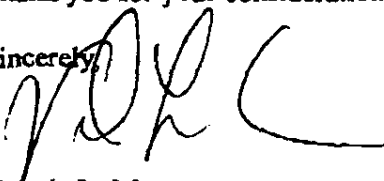
Less than one year ago I began a new small self employed business. I did not receive the enclosed form until this month.
