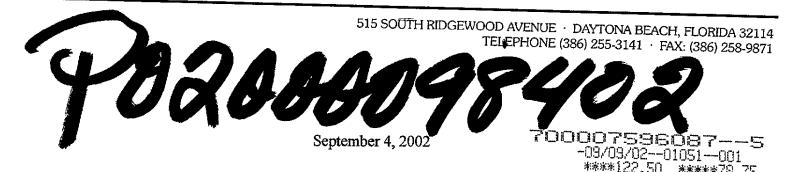

<u>ARTICLE L NAME</u>

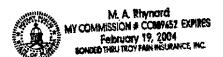

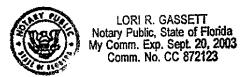
