**ARTICLES OF INCORPORATION
AOMI
ARCHITECTURAL ORNAMENTAL METALS, INC.**

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporations Act, hereby adopt the following Articles of Incorporation.

**ARTICLE I.
NAME**

The name of the corporation shall be: AOMI
ARCHITECTURAL ORNAMENTAL METALS, INC.

**ARTICLE II.
PRINCIPAL OFFICE**

The principal place of doing business and mailing address of this corporation shall be: 852 Carswell Ave., Holly Hill, FL 32117.

**ARTICLE III.
SHARES**

The number of shares of common stock that this corporation is authorized to have outstanding at any one time is 100. The shares are to be held by the directors of the corporation. Bill Proasi shall have 49 shares, and Raymond Alford shall have 51 shares. Each share of common stock carries with it one vote. No other classes of stock are authorized.

**ARTICLE IV.
INITIAL REGISTERED AGENT AND STREET ADDRESS**

The name and address of the initial registered agent is Barbara Fink, 1167 Buena Vista Dr., Holly Hill, FL 32117. The registered agent accepts the appointment as registered agent simultaneously with being designated, and she accepts the obligations of that position.

**ARTICLE V.
CONTINUITY OF CORPORATION**

The corporation shall continue until such time as the share holders or their successors elect to dissolve the corporation by a majority vote.

OTHER MATTERS**

By-Laws of the corporation will be drafted during the first year of incorporation.

Amendments to the Articles of Incorporation and/or By-Laws may be made at any time upon approval of a majority of the share holders or their successors.

The annual meeting will be conducted in January.

Each share holder has the right of first refusal for the sale or purchase of the other's shares of the corporation. The cost of a buy out shall be based on a valuation by an independent auditor.

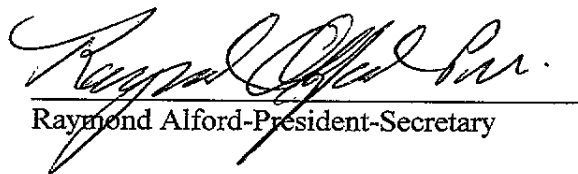
