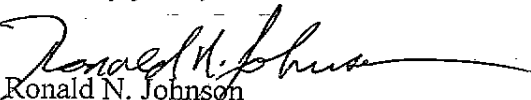

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

OCEAN SHORE CONTRUCTION, INC.

The principal place of business of this corporation shall be 3110 Johnson Anderson Blvd., Ormond Beach, Florida 32176, and the mailing address shall be Post Office Box 1446, Flagler Beach, Florida 32136.

ARTICLE II. NATURE OF BUSINESS

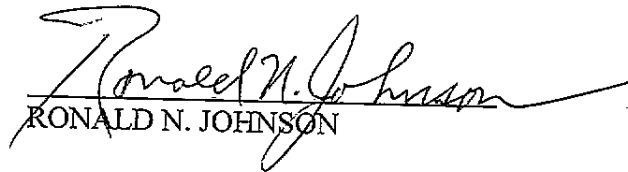

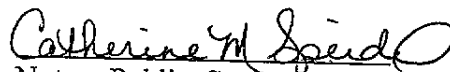

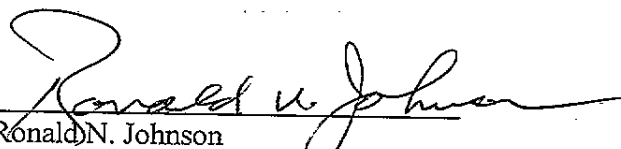
