
## ARTICLE IX AMENDMENT OF ARTICLES

## ARTICLE X INDEMNIFICATION



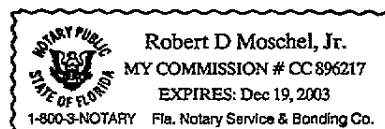


