# ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPOR

**OF** 

#### CENTER FOR RADIATION ONCOLOGY OF TAMPA BAY, IN

Pursuant to the provisions of Section 607.1006(1) of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

- 1. The name of the Corporation is Center for Radiation Oncology of Tampa Bay, Inc.
- 2. The following amendments to the Articles of Incorporation were adopted by the Directors and Shareholders of the Corporation on the 18<sup>th</sup> day of April, 2008, in the manner prescribed by the Florida Business Corporation Act:

Article 1 - is hereby amended by deleting the first sentence in order to change the corporate name as follows:

"The name of this Corporation shall be CRO OF TAMPA BAY, INC."

3. The number of votes cast for the amendment by the Shareholders was sufficient for approval.
