## **A FLORIDA CORPORATION**

The undersigned, acting as incorporator of **Smoke Cafe Inc.**, under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

### **ARTICLE I. NAME**

The name of the Florida Corporation is:
