ARTICLE X AMENDMENT

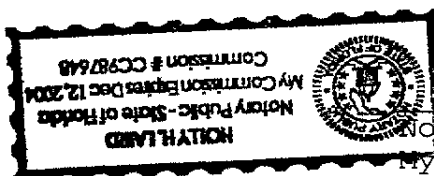
