The undersigned for the purpose of forming a Corporation for profit under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

Article II Purposes

The general purposes for which the corporation is organized is to transact any Name lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

Article III Capital Stock
