

ARTICLES OF INCORPORATION
OF
SUPERFUN GAMES, INCORPORATED

THE UNDERSIGNED, acting as sole incorporator of SuperFun Games, Incorporated, under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name and Office

Preemptive Rights Granted


Each shareholder of this corporation shall be entitled to full preemptive rights to purchase any unissued or treasury shares of the corporation.


