The undersigned, does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

<u>ARTICLE I – NAME</u>

The name of this corporation is **ENC ENTERPRISES**, **INC.**

ARTICLE II - PURPOSE
