## ARTICLES OF INCORPORATION **OF**

# ARTICLE 6 - CORPORATE CAPITALIZATION

- . 6.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is 1,000 Shares of common stock, each share having the par value of 0.10.

#### ARTICLE 10 - TITLE

The Corporation, to the extent permitted by law, shall be entitled to treat the person in whose name any share or right is registered on the books of the Corporation as the owner thereto, for all purposes, and shall not be bound to recognize any equitable or other claim to, or interest in, such share or right on the part of any other person, whether or not the Corporation shall have notice thereof.
