

# ARTICLES OF INCORPORATION OF

#### J. R. BILLIARDS, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

#### **ARTICLE I**

The name of the Corporation ("Corporation") is J. R. BiLLIARDS, INC.

#### ARTICLE II

The existence of the Corporation shall begin on September 13, 2002.

#### ARTICLE III

The street address of the principal office of the Corporation is 1397 Main Street, Dunedin, Florida 34698.

#### ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100, \$1.00 par value, all of which shall be Common Shares.
