ARTICLES OF INCORPORATION

OF

ACCESSIBLE CONSTRUCTION CONSULTING AND MANAGEMENT, INC.

THE UNDERSIGNED subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is ACCESSIBLE CONSTRUCTION CONSULTING AND MANAGEMENT, INC... ARTICLE II - NATURE OF BUSINESS

To the same extent as natural persons might or could do, the Corporation shall have the power:

- A. To carry on any lawful_business whatsoever which the Corporation may deem proper or convenient, or which may be intended directly or indirectly to promote the interests of the Corporation or to enhance the value of its property.
- B. To do all things contemplated by, and to have all powers set forth in, Chapter 607.011, Florida Statutes, 1983, and as amended thereafter.

ARTICLE IV - DURATION OF EXISTENCE

This Corporation is to have perpetual existence.

ARTICLE V - RESIDENT AGENT AND ADDRESS ___

The street address of the initial registered office of the Corporation in the State of Florida and principal place of business shall be 1157 Sarah Court, Dunedin, FL 34698 and the name of its initial Registered Agent at such address is Joseph Raetano. The corporation may have and establish offices, conduct business and promote its objectives within any part of the State of Florida, or in any state, District of Columbia, and territories and colonies of the United States and in foreign countries, as the Directors may designate.
