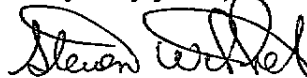

ARTICLE I

NAME

ARTICLE IX

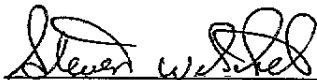
BYLAWS

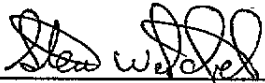
