ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is **SPEECH & TEXT, INC.** and its principal place of business shall be located at **2159 Fallbrooke Court, Tallahassee, Leon County, Florida 32308.**

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business with relation to the translation of documents and the provision of services of interpretation of foreign languages with relation to legal, medical and other matters.
