The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1. NAME. The name of the corporation is: J & J INTERNATIONAL TRUCKING COMPANY, INC.

ARTICLE 2. PRINCIPAL PLACE OF ADDRESS: 555 Jefferson Drive Unit #112 Deerfield Beach, FL 33442.

ARTICLE 3. PURPOSE. The general purpose for which the corporation is organized are the following:
