ARTICLES OF INCORPORATION
Rogers United Inc.

ARTICLE 1

Name: The name of the Corporation is Rogers United Inc.

ARTICLE 2

Duration: The period of duration of this corporation is perpetual.

ARTICLE 3

Purpose and Powers: This corporation may engage in any activity of business permitted under the laws of the United States and the State of Florida.

Specific Nature of Business: The Company is engaged in the business of debt consolidations.

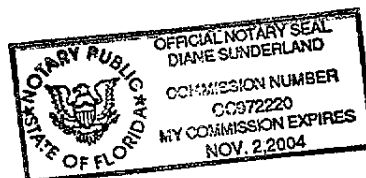
