### ARTICLE I - NAME

The name of the corporation shall be OXFORD BTM, INC. mailing address for the corporation is 6578 Palmer Park Circle, Sarasota, Florida 34238-2777.

### ARTICLE II - DURATION

This corporation shall exist perpetually.

### ARTICLE III - PURPOSE

**ARTICLE XIII - DATE OF COMMENCEMENT**

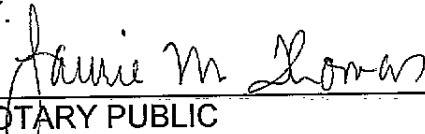

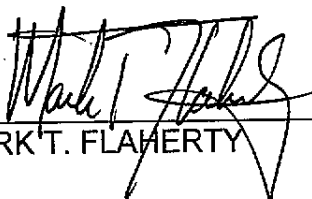
