**ARTICLES OF INCORPORATION

In compliance with the requirements of Florida Statutes chapter 607, the undersigned hereby executes, acknowledges and files the following Articles of Incorporation for the purposes of organizing a business corporation under the laws of the State of Florida.

ARTICLE I (CORPORATE NAME)

The name of the corporation ("Corporation") shall be SECURE WINGS, INC.

ARTICLE II (PRINCIPAL OFFICE)

The street address of the principal office of the Corporation is Suite 202-B, 2299 Douglas Road, Miami, Florida 33145. The Board of Directors from time to time may move the principal office to any other address in the State of Florida.

ARTICLE III (CAPITAL STOCK)

The maximum number of shares which the Corporation is authorized to issue is one thousand (100) shares having a par value of one dollar (\$1.00) per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE IV (INITIAL REGISTERED OFFICE AND AGENT)

The initial street address of the Corporation's registered office is Stack Fernandez Anderson & Harris, P.A., Suite 950, 1200 Brickell Avenue, Miami, Florida 33131. The initial registered agent is Robert Harris, Esq. The Board of Directors

from time to time may move the registered office to any other address in the State of Florida.

ARTICLE V (BOARD OF DIRECTORS)

The initial Board of Directors of the Corporation shall consist of one (1) member. The names and addresses of the individual who will serve on the initial board is Armando Colosimo, Suite 202-B, 2299 Douglas Road, Miami, Florida 33145. The number of directors may be increased or diminished from time to time by Bylaws adopted by the shareholders, but shall never be less than one.

ARTICLE VI (PREEMPTIVE RIGHTS)

The Corporation elects to have preemptive rights.

ARTICLE VII (INDEMNIFICATION)

The Corporation shall indemnify its directors, officers, employees and agents to the fullest extent permitted by law.

ARTICLE VIII (INCORPORATOR)


