ARTICLE I. NAME

The name of this corporation is Unlimited Fabrications, Inc.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business is 31096 Building 2, Highway 27, Lake Hamilton, Florida 33851.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business, including but not limited welding.
