ARTICLES OF INCORPORATION OF GPS CONSULTING, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I Name

Section 1.1. Name. The name of this corporation shall be GPS Consulting, Inc.

Article II <u>Principal Office and Mailing Address</u>

Section 2.1. Principal Office and Mailing Address. The principal place of business and mailing address of this corporation shall be 13451 Owl Hollow Court, Jacksonville, Florida 32223.

Section 6.1. <u>Duration</u>. This corporation shall exist perpetually.
