



- (d) To enter into, make and perform contracts of every nature, sort and description, which may be necessary or convenient to the carrying ont of this business, with any person, firm, association, corporations, municipality, body politic, county, state or government or dependency agency thereof.
- (c) To create, construct, develop, operate, plan and produce any and all types, forms and kinds of advertising media of whatsoever kind and nature or promotion of sales, development of any product or products or any part thereof, without restrictions or limit as to amount in any State of the United States or clsewhere.
