In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation (the "Corporation") is Mustang Building, Inc.

**ARTICLE II**

The principal place of business and mailing address of the Corporation is: Post Office Box 1446, Palm Harbor, Florida 34682.

**ARTICLE III**

The Corporation is being incorporated for the purpose of conducting business that is legal for a Corporation to conduct in the State of Florida.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is one thousand (1000), all of which shall be Common Shares with par value of one cent (\$0.01) per share.
