I, the undersigned, being of legal age and natural person, so hereby subscribe to acknowledge and file the following Articles of Incorporation for the purposes of creating a Corporation under the State of Florida.

ARTICLE I

The name and initial address of this Corporation shall be: Lawrence Ventures Inc
1527 S. Flagler Dr. Apt. 313, West Palm Beach, Florida
33401, with the privilege of having its offices and branch offices at other places within or without the State of Florida.

ARTICLE II

This Corporation may engage in any activity or business permitted under the laws of the State of Florida.

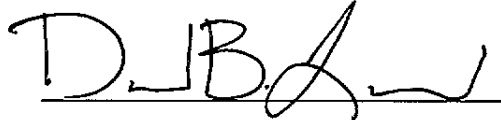
ARTICLE IX

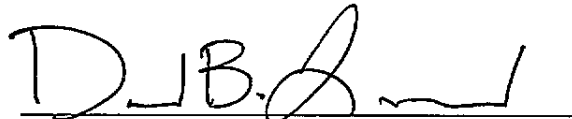
In compliance with the laws of the State of Florida, the following is submitted:
