The undersigned incorporator, for the purpose of becoming a Corporation under the General Corporation Laws of the State of Florida, providing for the formation, liabilities, rights privileges and immunities of a corporation for profit, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation hereby formed under these Articles shall hence, and from this day, subject to the approval of the Secretary of State, State of Florida, be known as FERRETERIA LA CAMPANA, INC.. The principal place of business of this corporation shall be : 2477 Quail Roost Dr., Weston, Florida 33327.

ARTICLE II - OBJECTIVE

FERRETERIA LA CAMPANA, INC.. shall have as its principal business objective the operation of an import & export company in full and complete compliance with the Laws of the State of Florida and to conduct all business purposes set forth by said statutes. 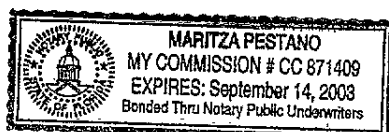


