# ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE I: NAME

The name of the corporation shall be: PETRA & ANNE BIJOUX, INC.

### ARTICLE II: NATURE OF BUSINESS

The Corporation will mainly operate a Manufacturing Factory producing Custom Jewerly and will promote, distribute, and sell its own products and other imported goods at retail and/or wholesale, but may engage in any activity or business permitted under the laws of the United States and the State of Florida.

### ARTICLE III: CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any time is one thousand (1,000) shares, of one dollar (\$1.00) par value per share.

## ARTICLE IV: INITIAL CAPITAL

The amount capital with which this corporation will begin business will not be less than one thousand dollars (\$1000.00).
