ARTICLES of INCORPORATION  
of  
BRADLEY CONSULTING GROUP, Inc.

The undersigned incorporator(s) under these Articles of Incorporation, in order to form a corporation under the laws of Florida, hereby certify:

ARTICLE 1 - The name of the corporation is:

BRADLEY CONSULTING GROUP, Inc.

ARTICLE 2 - This corporation is to exist perpetually.

ARTICLE 3 - The general purposes for which this corporation

is organized is:

(a) To engage in the business as aviation consultants, dealing with the business of organizing and re-organizing aviation and airline businesses, airline corporations and stock interests therein, airline management, operations and services, as well as aircraft, and all matters, problems and allied projects connected therewith and to engage in such other activities as are incidental to or connected with the operation of such business; including, but not limited to the buying, selling, leasing, organizing and re-organizing of airlines, airline companies and aviation related businesses and the stock interests therein, as well as the buying, selling, leasing and manufacturing of aircraft, aircraft parts, aircraft engines and any aircraft components, both at wholesale as well as retail, and as principal, agent, consultant, broker, commission men, factors for buyers and sellers, both foreign and domestic.

(b) To engage in the business of transportation, freight forwarding, and movement of cargo and property for hire by motor vehicle, aircraft, watercraft, and other means of conveyance, as a common carrier, or otherwise; and furnishing every kind of support service to trucking companies, shipping companies and airlines, including, but not limited to administration, office personnel, cargo handling, motor vehicle, vessel and aircraft maintenance, ticket handling and cargo ticket sales and promotion, import and export documentation and services, custom documentation and any other service in connection with the transportation business, both at wholesale or retail, as principal or agent, and any other business in connection therewith.

(c) To carry on the business of growing, harvesting, import and export of general merchandise, foodstuffs, mercantile goods and wares and any other goods, merchandise or products of every kind and

description in all foreign and domestic markets, to act as consultants, brokers, commission men, factors and agents for buyers and sellers, both foreign and domestic. To purchase and sell goods that are permitted by the laws of the United States to be handled in interstate commerce, and world foreign trade. To acquire, use, and operate equipment, materials, and supplies, and maintain all things necessary to effect the purpose and objectives that are required in this type of business as above and herein generally described.

(d) To do anything which a corporation may lawfully do under the laws of the State of Florida.

ARTICLE 4- The street and mailing address of the initial principal office of the corporation is: 657 South Drive, Miami Springs, Florida 33166.

ARTICLE 5- The aggregate number of shares of stock which the corporation shall have authority to issue is 100 shares of no par value, capital stock.

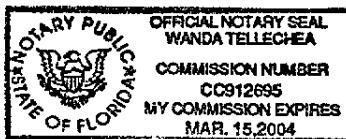
