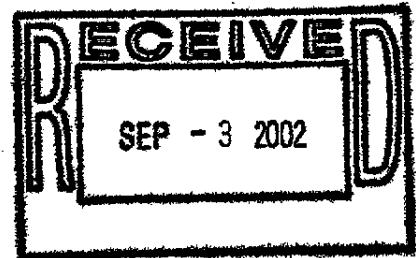

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is SNP Contractors, Inc.

ARTICLE TWO

The duration of the corporation is to be perpetual.

ARTICLE THREE

The general purpose for which the corporation is organized are:

1. To engage in the business of general contracting.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporations Act.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE FOUR

The aggregate number of shares which the corporation is authorized to issue is 100. Such shares shall be of a single class, and shall have a par value of \$1.00. All stock issued shall be held of record by not more than ten (10) persons. Stock shall be issued and transferable to natural persons who are not nonresidential aliens.

ARTICLE FIVE

The street address of the principal office of the corporation is: 102 East Tillman, Lake Wales, Florida 33853. The street address of the initial registered office of the corporation is: 102 East Tillman, Lake Wales, Florida 33853. The designated registered agent at that address is: Harry Parks.

ARTICLE SIX

The power to adopt, alter, amend, or repeal by-laws shall be vested in the board of directors and the shareholders.

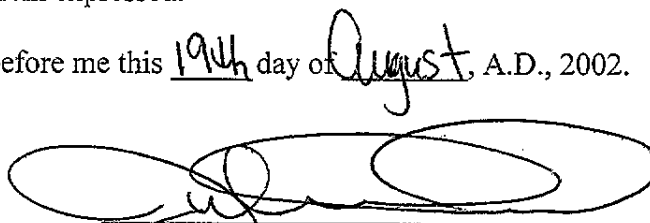

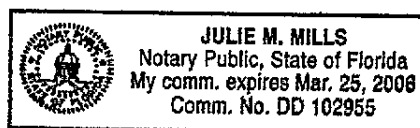
