ARTICLE I

NAME

The name of the Corporation is **Cyberdata Installations, Inc.** The principal office address and the mailing address of said Corporation is 203 Cardinal Street Yulee, Florida 32041.

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
