ARTICLE VII- INITIAL REGISTERED OFFICE AND AGENT



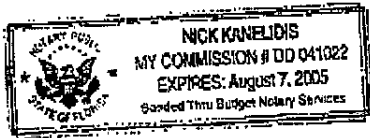


