

ARTICLES OF INCORPORATION OF



Vergina, Inc.

The undersigned incorporator, for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the Corporation is:

Vergina, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and the mailing address of this Corporation are:

ARTICLE III: NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in any and all business with all the powers permitted under the laws of the State of Florida.

ARTICLE IV: CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding is 7,500 shares of common stock having a par value of ONE (\$1.00) DOLLAR per share.

ARTICLE V: COMMENCEMENT AND DURATION OF TERM OF EXISTENCE

This Corporation shall have perpetual existence.
