A Florida Profit Corporation

(Pursuant to Chapter 607 and/or 621, Florida Statutes)

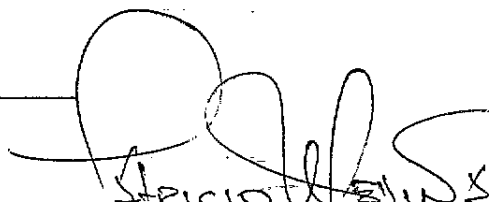
