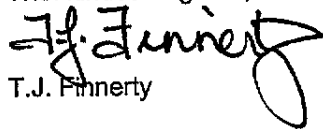

ARTICLES OF INCORPORATION

OF

HALL'S LANDSCAPING, INC.

ARTICLE I - NAME

The name of this Corporation is: Hall's Landscaping, Inc.

The Corporation shall have a perpetual existence.

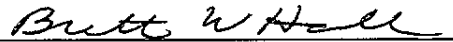

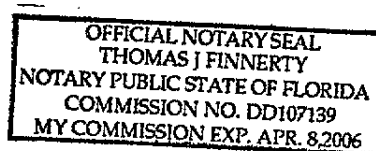
