
ARTICLE - VIII - DIRECTORS



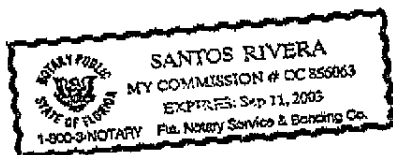
