

ARTICLES OF INCORPORATION



OF

LONE EAGLE INVESTMENT GROUP, INC.

The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this corporation shall be: Lone Eagle Investment Group, Inc.

Business and Purposes

Schifino. This corporation shall have the right to change such registered office and such registered agent from time to time, as provided by law.
