

# ARTICLES OF INCORPORATION

### **FOR**

#### AMERICAN FAMILY CLUB, INC.

The undersigned, acting as incorporate(s) of a Corporation pursuant to Chapter 607 Florida Statutes, adopt(s) the following Articles of Incorporation.

#### ARTICLE I NAME
