

The corporation shall indemnify each officer to the full extent permitted by law.

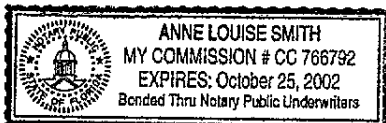
