ARTICLES OF INCORPORATION

OF

ARTICLE I

The name of the corporation is RCMA INVESTMENTS I, INC., (the "Corporation").

ARTICLE II

The number of directors constituting the initial Board of Directors is two (2), and the name and address of each member of the initial Board of Directors, who is to serve as the Corporation's director until successors are duly elected and qualified is:
