ARTICLES OF INCORPORATION

ARTICLE I - NAME

The Name of the corporation is Y.S. Maintenance, Inc.

ARTICLE II - DURATION

The corporation shall have perpetual existence, commencing the date of filing of these articles, unless sooner dissolved according to law.



#### ARTICLE XI - AMENDMENT


