**ARTICLES OF INCORPORATION
OF
DURR & ASSOCIATES, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation

**ARTICLE I
NAME**

The name of the corporation is Durr & Associates, Inc. (hereinafter called the "Corporation").

**ARTICLE II
