ARTICLES OF INCORPORATION

OF

The undersigned incorporator, for the purpose of forming a corporation under the Planda Business Corporation Act, adopts the following Articles of Incorporation

ARTICLE I NAME

The name of the corporation is Durr & Associates, Inc. (hereinafter called the "Corporation").

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS
