ARTICLES OF INCORPORATION  
FOR

ARTICLE I

The name of this corporation is OSCAR TOLEDO, P.A.

ARTICLE II

This corporation is organized for the purpose of engaging in transacting any lawfull business permitted under the laws of the United States and the State of Florida. The principle business activity of this corporation is real estate services.

The term for which this corporation shall exist shall be perpetual.
