**ARTICLES OF INCORPORATION**

The undersigned incorporators to these Articles of Incorporation, natural persons competent to contract, hereby present these articles of incorporation for the formation of a corporation under the applicable laws of the State of Florida.

**ARTICLE I. NAME**

The name of this corporation is Psychology and Rehabilitation Services, P. A.

**ARTICLE II. CORPORATE DURATION**

The duration of the corporation is perpetual.

**ARTICLE III. PURPOSE**

This corporation is organized for the following purposes:

- a. To engage in the practice of psychology as a professional corporation and to provide psychological care and treatment.
- b. To promote psychological research and knowledge; to furnish related clinical services; and to own real and personal property, enter into contracts, and engage in any lawful business necessary for the rendering of the professional psychological services.
- c. To do everything necessary, proper, or convenient to accomplish any of the purposes set forth in these articles, and to do every other act incidental to the corporate purposes which is not forbidden by Florida laws or by the provisions of these articles of incorporation.

The purposes of these articles shall be carried out only through officers, employees, and agents, each of whom is licensed or otherwise legally qualified to

render professional psychological services in the State of Florida.

#### ARTICLE IV. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is 2425 Mill Court, Suite 1, Tallahassee, Florida 32308.

#### ARTICLE V. CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any one time is One Hundred (100) shares. Such shares shall be of a single class of stock, and all issued stock shall be held of record by not more than 75 persons. All shares of stock shall have a par value of Five Dollars (\$5.00) per share. Stock shall be issued and transferred only to persons duly licensed or authorized by law to practice the profession of psychology in the State of Florida. The corporation has or will make an election to be treated as a Subchapter S corporation for purposes of the Internal Revenue Code. Additionally, a stockholder desiring to dispose of any stock, shall first give written notice to that effect to the corporation and to the other stockholders and offer the stock for sale first to the corporation, then to the other stockholders.

#### ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The name of the initial registered agent of this corporation is Tammy Mae Chapman, Ph.D. The address of the initial registered office and registered agent of this corporation is 2425 Mill Court, Suite 1, Tallahassee, Florida 32308.

#### ARTICLE VII. INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be either increased or diminished from time to time by the bylaws, but shall never

be less than one. The names and address of the initial director of the corporation is:

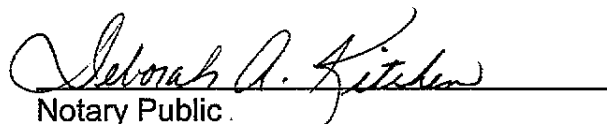
