The undersigned, acting as incorporator of a professional corporation under Chapter 621 of the Florida Statutes, adopts the following articles of incorporation for such corporation (the "Corporation"):

ARTICLE I

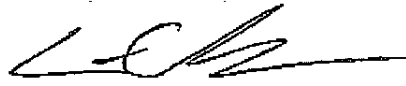
