OF

The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be Inteltech Corporation.

ARTICLE II - COMMENCEMENT & DURATION

ARTICLE VIII - SHAREHOLDER PROPERTY


