**ARTICLES OF INCORPORATION
OF

(a Florida corporation)

THE UNDERSIGNED, acting as sole incorporator of **MR. ADOBO, INC.**, under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name


