**ARTICLE I. CORPORATE NAME.**

The name of this corporation is CUT & STACK, INC.

**ARTICLE II. PRINCIPAL OFFICE.**

The principal place of business and mailing address of this corporation are 102 Southeast Fourth Terrace, Dania Beach, Florida 33004.

**ARTICLE III. CAPITAL STOCK.**

The number of shares of stock that this corporation is authorized to have outstanding at any one time is one hundred (100).

**ARTICLE IV. INITIAL REGISTERED AGENT AND OFFICE.**

**ARTICLE VI. DURATION OF CORPORATION.**

The duration of the corporation is perpetual.

**ARTICLE VII. PURPOSE.**

#### ARTICLE XI. RIGHTS AND POWERS.

The corporation shall have all the rights and powers now or subsequently conferred on professional corporations by the laws of the State of Florida.

#### ARTICLE XII. ACCEPTANCE OF DESIGNATION AS REGISTERED AGENT.

Having been named as registered agent and designated to accept service of process for the above corporation, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent.

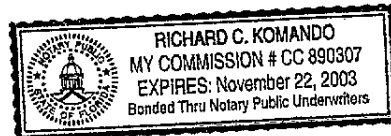
