## ARTICLES OF INCORPORATION OF CRUM & SONS, INC.

EFFECTIVE DATE

The undersigned, acting as incorporator of a corporation for profit under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

#### ARTICLE I.

NAME: The name of this corporation is CRUM & SONS, INC. and the principal place of business shall be 128 Maple Road, Freeport, FL 32439.
