Dear Sir:

The owner and registered agent of Out & About, Inc., David E. Gaige, Jr., recently received the 2003 For Profit Corporation Uniform Business Report requesting a filing fee to the Florida Department of State for \$550. Mr. Gaige did not receive any previous form or notification of the Uniform Business Report prior to this notice. His lack of payment by May 1 was not due to negligence, neglect, or fraud, but to his inexperience with corporate filings. This is the owner's first enterprise operating as a corporation, and 2003 is the corporation's first year of operation, so the owner is not familiar with the annual filing requirements with the Florida Department of State. If the owner had received the initial form, he would have filed before the May 1 deadline.

The \$550 fee for filing after May 1 is a hardship on the owner, since his operating cash account balance at the end of October 2003 was only \$251.06. Enclosed is the signed 2003 UBR. Please abate the \$400 late filing penalty due to fact that the owner did not receive the form on time and was unaware of the filing responsibility. If this is not acceptable, the owner will be forced to dissolve the corporation and open a new corporation since he cannot afford the \$550 fee. Please review the case and inform the registered agent of your decision. Thank you for your attention to this matter.
